

Commentary:-

- O Rupee opened on negative note with a loss of 514 paise at 65.22/USD against previous close of 65.17/USD. Ahead of Fed Interest Rate announcement USDINR traded sideways. Thus rupee depreciated mildly by 2 paise and closed at 65.17/USD.
- O NIFTY opened on lower levels following to global cues. Finding support near 10050 mark we observed NIFTY inching up higher. Thus to wrap up the day, NIFTY closed on positive note with a gain of 30 points (or 0.30%) at 10124 mark.
- O FIIs were net buyer on last trading session for Rs344.16 cr.
- O USDINR spot is expected to trade in a range of 65 to 65.50/USD levels.
