

Commentary:-

○ Rupee opened on mild higher at 73.83/USD. But considering the positive macro economic data as well as softness in crude oil prices, we observed rupee appreciating further and to wrap up the session, rupee closed with a gain of 37 paise at 73.46/USD.

○ NIFTY opened gap up with a gain of 38 points at 10550 mark. After posting day high i.e.10605 mark, NIFTY remained shy to the levels and remained sideways for the day. Thus to end the session, NIFTY closed with a gain of 73 points (or 0.69%) at 10585 mark.

○ FII's were net Seller on last trading session for Rs1165.63 cr.

○ USDINR spot is expected to trade in a range of 73 to 73.60/USD levels.
